

# Pirkkala water management service price list 1 January 2024, VAT change added

Tampere Water is responsible for the water management maintenance of the Pirkkala municipality as well as for the customer service according to this price list.

## 1. Usage and basic fees

The water and waste water usage fees applicable in Pirkkala are tied to the usage fees that are valid in Tampere, with a multiplier of 1.20. The basic fees are the same in Pirkkala and Tampere.

### 1.1. Usage fee

In addition to the basic fee, a fee of EUR 1.33/m<sup>3</sup> + EUR 0.32 (VAT 24%) = EUR 1.65/m<sup>3</sup> will be charged for temporary water, measured with a temporary water meter or according to the estimated use. As of September 1, 2024, VAT will increase from 24 % to 25,5 %. If a fire hydrant meter has been damaged during use, the repair costs of the meter and the final readings of the meter plus 100 m<sup>3</sup> as a usage fee will be invoiced.

## 2. Fees related to connecting to the network

### 2.1. Connection fee

A connection fee will be charged when a new building is connected to the water supply and/or sewer network. The amount of the fee is dependent on the type of the property and permitted building volume. You can request a connection fee calculation from the number +358 040 806 2747 or [vesi.karttapalvelu@tampere.fi](mailto:vesi.karttapalvelu@tampere.fi). The annually revised unit price of the connection fee is linked to the changes of the total index of construction. For instance, the connection fee of a detached house under 250 m<sup>2</sup> is EUR 6,420, of which the proportion of water is EUR 2,568, waste water EUR 3,210 and drainage water EUR 642. There is a calculator for calculating the average connection fee available on the Tampere Water website. The fee does not include valued added tax (for non-taxable connection parties).

### 2.2. Building of the beginnings of the service pipes

If service pipes for the plot at the boundary of the plot have not been built in conjunction with new construction projects, the property owner can have them built by Tampere Water based on a quote or by another contractor. Tampere Water will connect the property from the core network and to the water meter in the property and invoice the work.

### 2.3. Extending the service pipes of detached houses from the boundary of the plot to the property's water meter

Installing the water pipe into an open excavation, including work and material costs (d 40 mm, length less than 30 m). It must be taken into account that the excavation work for the water and sewer pipes on the plot will be carried out by the contractor of the developer.

### 2.4. Building of the beginnings of the service pipes by the municipality of Pirkkala in connection with the construction of a new residential area

The prices include installation, opening and closing of the excavation as well as finishing of the surfaces including materials to the proximity of the boundary of the plot. The construction costs of the service pipes that are higher than the above-mentioned connection costs will be determined according to the actual construction costs. The construction cost is linked to the total construction index based on the September index of the previous year. The fee is defined based on the price list of the year when the building permit was granted.
